MINUTES

1. Roll Call

Lorie Zapf, Chair of the Committee, called the Taxicab Advisory Committee meeting to order at 10:07 a.m. A roll call sheet listing Taxicab Advisory Committee member attendance is attached.

2. Approval of Meeting Minutes – September 14, 2016

Ms. Zapf moved for approval of the minutes of the September 14, 2016, Taxicab Advisory Committee meeting and the vote was 12 to 0 in favor with Mr. Mayekawa, Ms. Mercer, Ms. Tanguay and Mr. Terzi absent.

3. Non-Agenda Public Comment

Abebe Antallo – Stated he was a lease cab driver and an organizer of the United Taxi Workers of San Diego (UTWSD). He noted that he was involved in pushing the city to lift the cap on taxicab permits and he is now an owner operator. Mr. Antallo suggested he is not making money due to Uber and Lyft and what he believes is unfair regulation. He would like the city and MTS to fight against Uber and Lyft because they are a threat to his livelihood.

4. Management and Committee Member Communications

a. Administrative Penalty Guidelines Revision

Mr. Kellerman stated with industry and driver concerns, along with permit holder requests the Taxicab Administration has reduced some of the administrative penalties. He noted many of the changes were the reduction of suspensions for second offenses; from a three day suspension to a two day suspension. Mr. Kellerman also mentioned some of the five day suspensions were reduced to three day suspensions. The revisions were submitted to the San Diego Metropolitan Transit System (MTS) Chief Executive Officer and he approved and signed off on the revisions. Mr. Kellerman reminded the Taxicab Advisory Committee members that the administration tried to be sensitive to the needs of the industry, while maintaining the need for public safety.

Public Comment

Abdi Abdul – Representing the United Taxi Workers of San Diego (UTWSD) stated the UTWSD submitted some recommendations for the Administrative Penalty Guidelines in 2010 and 2012 and he believes the changes have not been implemented or considered. He is requesting the changes to be implemented.

Mr. Tasem inquired about the specific changes the UTWSD requested and why did it take the UTWSD so long to follow up. After some discussion, Mr. Abdul suggested not being able to go beyond 100 feet from their taxicab is unreasonable. Ms. Cooney recommended re-visiting what was submitted. Ms. Zapf noted Mr. Kellerman did not manage the Taxicab Administration at that time and advised Mr. Abdul to connect with staff to review what was submitted in 2010 and 2012.

Mr. Afifi displayed a taxicab driver ticket, and explained the driver parked in a taxicab stand, went to the restroom and got a ticket. He stated others are able to park and taxicabs are not. Mr. Afifi also wanted to address being stopped and questioned for trip sheets or not having a badge on. Mr. Kellerman reiterated that anything that could compromise public safety was not considered in the penalty guideline revisions and mentioned the trip logs are safety measures for the public. Mr. Kellerman is willing to consider anything reasonable and anything that does not compromise public safety. It was suggested another meeting take place to go line-by-line over the Administrative Penalty Guidelines. Mr. Hueso inquired about the monetary amounts on the penalty guidelines. Mr. Kellerman clarified the document Mr. Hueso was inquiring about was the Fee Schedule. It was noted the Fee Schedule is under review and it has not been published yet due to the mid-year budget review and the annual fees being one of the line items being considered for revision.

b. San Diego County Regional Airport Authority Inspection Results

Mr. Kellerman reviewed the results from the taxicab inspections that took place at the San Diego International Airport on October 11, 2016. It was a joint effort with the San Diego County Regional Airport Authority (SDCRAA), San Diego County Sheriff's Licensing Department and San Diego County Agriculture, Weights and Measures. The inspections took place at the airport holding lot located on Harbor Drive. Ninety-five vehicles were inspected on October 11, 2016. Fourteen taxicabs were taken out of service that day. Mr. Kellerman stated staff was available throughout the day for the taxicabs to come back to the airport with the violations corrected; this allowed the taxicabs to immediately go back into service. Fifteen taxicabs received seventy-two hour notices and Mr. Kellerman stated the airport dealt with those corrections. Mr. Kellerman mentioned most of the vehicles were in pretty good condition and the drivers were largely complaisant.

c. Customer Service Enhancement and New Owner Orientation Programs – Tony Hueso

Mr. Hueso stated with the addition of the new permits in the city, as a group, he would like to create a program to enhance services for the community. He believes the industry can do better. It was proposed a subcommittee be created to connect the city, other agencies, and the hotel-motel industry to exchange dialogue. Mr. Hueso would like to help the underserved and the city as a whole. Mr. Hueso also suggested a program to orient new drivers that are trying to get into the business. Chairperson Zapf supports Mr. Hueso's idea. Mr. Afifi mentioned a meeting with Mr. Tasem and Mr. Kellerman

regarding customer service. He cited the San Diego Metropolitan Transit System's (MTS) new digitalized signs at bus stops and thought it would be helpful to have a revolving list of taxicab dispatchers displayed for the public. Chairperson Zapf suggested that idea would be better discussed at the subcommittee level. Mr. Kellerman stated he would be able to facilitate and host an ad-hoc committee or subcommittee, and suggested soliciting interest from the Taxicab Advisory Committee (TAC) membership. Mr. Hueso proposed a subcommittee meeting before the next TAC in March 2017. Mr. Chasteen mentioned he would be willing to work with Mr. Hueso on this program.

5. MTS Taxicab Administration Fiscal Year 2017 Amended Budget

Mr. Kellerman introduced Lucas Kromer, Operating Budget Supervisor, from the San Diego Metropolitan Transit System (MTS) Finance Department. Mr. Kromer provided a PowerPoint presentation of the MTS Taxicab Administration Fiscal Year 2017 Mid-year Amended Budget. Mr. Kromer reminded the committee that the Taxicab Administration works on a full cost recovery basis. Two options were offered to the Taxicab Advisory Committee (TAC) to reduce the contingency reserves. The first offer was Option A utilizing \$450,000.00 of contingency reserves to set the annual renewal fee at \$300.00 for fiscal year 2017 and adjust back to \$600.00 in fiscal year 2018. Option B is to utilize \$450,000.00 of contingency reserves to set the annual renewal fee at \$450.00 for fiscal year 2017 and fiscal year 2018.

Action Taken

Mr. Hueso moved to utilize \$450,000.00 of contingency reserves to set the annual regulatory fee at \$300.00 for fiscal year 2017 and adjust back to \$600.00 in fiscal year 2018. Mr. Majid seconded the motion, and the vote was 12 to 1 in favor with Mr. Mayekawa, Ms. Mercer and Mr. Terzi absent.

DISCUSSION:

The contract between MTS and Foundation Community Services to provide the MTS approved Driver Training Program is due to expire on November 21, 2017. On May 26, 2017, the Workshop on Regulatory Matters sub-committee voted to forward the following recommendations on options to the Taxicab advisory Committee for further consideration:

- That MTS seek bids with similar third party providers for the implementation of the Driver Training Program. This option would allow the training program



provider to remain neutral and for drivers to be free of any possible influence or efforts by the provider to encourage drivers to work for any particular taxicab company.

- To allow and make individual Taxicab Companies or Radio Services organizations responsible of providing their Drivers with the MTS approved driver training program
- To seek a three to six month contract extension with Foundation Community Services, allowing stakeholders more time to explore further options and provide feedback leading to revisions of the training program. On June 6, 2017 Foundation Community Services Director Tibisay Lampley, notified MTS of Foundation Community Services intention not to renew or extend the current contract to provide the Driver training program. Therefore, this option is no longer feasible.
- On 5/26/2017, after the WORM subcommittee meeting, an additional option has arisen. To conduct further discussions at the WORM subcommittee focusing on evaluating the planning, guidelines and overall feasibility for MTS Taxicab Administration becoming the sole provider of the Driver Training Program. This option would allow for direct stakeholder involvement in revising the current training program as well as continuity in the current implementation of the program.

RECOMMENDATION:

That the Taxicab Advisory Committee:

1. hold a public comment, receive testimony, and review comments on the proposed taxicab rates of fare; and
2. forward a recommendation to the MTS Board of Directors to stabilize the current 2016 rates of fare for both Airport Originated Trips and Non-Airport Originated Trips for the remainder of 2017, until recalculation in 2018.

Budget Impact:

None.

DISCUSSION:

Annually, the MTS Taxicab Administration recalculates both the maximum allowable City rates of fare and the airport taxicab rates of fare.

In accordance with *MTS Ordinance No. 11*, Section 2.2 (b), which states, "Taxicab trips from the San Diego International Airport shall be at a uniform rate of fare," *MTS Policies and Procedures No. 34* (Attachment A), Section 34.5.1, provides that, "Airport rates shall be adjusted ... in accordance with the change in the Annual All Urban Western Transportation Consumer San Diego Price Index" (Attachment B).

For rates of fare for taxicab trips that do not originate at the San Diego International Airport, MTS Ordinance No. 11, Section 2.2, and Policies and Procedures No. 34,



Section 34.4, provide for all MTS taxicab permit holders to file rates of fare that do not exceed 20 percent above the average rates on file for all taxicab vehicles, except for trips originating at the San Diego International Airport, and provided that they are consistent with the rates of their radio service.

Both City rates and airport taxicab rates of fare are to be calculated annually. The last time airport rates of fare were calculated was in March 2016. Therefore, staff has recalculated the rates of fare for 2017.

Results of staff's calculations of rates of fare for the San Diego International Airport as follows:

<u>Current Rates</u>	<u>Proposed 2017 Rates</u>
\$ 2.80 flag drop 1/10 of a mile	\$ 2.60 flag drop 1/14 of a mile
\$ 3.00 per mile	\$ 2.80 per mile
\$24.00 per-hour waiting time	\$22.00 per-hour waiting time

Maximum rates of fare for trips not originating at the airport are as follows:

<u>Current Rates</u>	<u>Proposed 2017 Rates</u>
\$ 3.40 flag drop 1/12 of a mile	\$ 3.40 flag drop 1/12 of a mile
\$ 3.60 per mile	\$ 3.60 per mile
\$29.00 per-hour waiting time	\$29.00 per-hour waiting time

On May 26, 2017, the Workshop on Regulatory Matters (WORM) sub-committee voted that the Taxicab Advisory Committee (TAC) make a recommendation to the MTS Board of Directors, to stabilize the current 2016 rates for the remainder of 2017, (Attachment C), as occurred on June 20, 2013, via San Diego Metropolitan Transit System Resolution No. 13-17 (Attachment D).

Board Approval: 04/16/15

SUBJECT:

FOR-HIRE VEHICLE SERVICES

PURPOSE:

To establish a policy with guidelines and procedures for the implementation of MTS Ordinance No. 11.

BACKGROUND:

Regulation of for-hire vehicle service is in the interest of providing the citizens and visitors to the MTS region and particularly the Cities of El Cajon, Imperial Beach, La Mesa, Lemon Grove, Poway, San Diego, and Santee, with a good quality local transportation service. Toward this end, MTS finds it desirable to regulate the issuance of taxicab permits, to establish maximum rates of fare, and to provide for annual review of cost-recovery regulatory fees.

POLICY:

34.1 City of San Diego Entry Policy

New City of San Diego taxicab permits will be issued in accordance with San Diego City Council Policy No. 500-02, "Taxicab Permits".

34.2 Maximum Fare Policy

Pursuant to MTS Ordinance No. 11, Section 2.2(a) and after a duly noticed and open public hearing, MTS determined that the maximum rate of fare for exclusive ride and group ride hire of taxicabs shall be that fare that does not exceed twenty percent (20%) more than the weighted average of fares as established in accordance with this policy.



34.2.1 Maximum Fare Determination

The weighted average of fares shall be computed by the Chief Executive Officer and duly promulgated in writing upon the passage of this policy and thereafter each year by averaging each segment of the fare structure of all MTS taxicab permit holders. The fare structure shall consist of the dollar amounts charged by said permit holders for the flag drop, the per-mile charge, waiting-time charge, first zone, and each additional zone charge. The weighted average of these charges shall be arrived at by adding each segment of each respective charge and dividing it by the total number of taxicabs holding effective permits.

34.2.2 The Chief Executive Officer will use his discretion when the maximum rates of fare and the uniform rates of fare for trips from Lindbergh Field airport are incompatible. The Chief Executive Officer may adjust the maximum rates of fare so that the uniform rates of fare, based on the change in the Annual All Urban Western Transportation Consumer Price Index, do not exceed the maximum rates allowed in accordance with Section 34.2.1.

34.3 Airport Taxicab Fare Policy

Rates of fare for trips from Lindbergh Field Airport shall be uniform.

In the event an owner chooses a different rate for nonairport trips for taxicabs authorized to service the airport, two meters or a multirate meter shall be installed and identified. The meter(s) shall be activated according to the proper rate for the trip's origin, and it shall be clearly visible to the passenger which rate is being charged.

34.3.1 The uniform rates of fare for taxicab trips from Lindbergh Field Airport are initially established at \$1.40 flag drop, \$1.50 per mile, and \$12.00 per hour, effective June 1, 1990.

The airport rates shall be reviewed annually, beginning in January 2009, by the Chief Executive Officer. Airport rates shall be adjusted based on the 1990 amounts, in accordance with the change in the Annual All Urban Western Transportation Consumer Price Index/ San Diego. Adjustments shall be rounded up or down, as appropriate, to the nearest even \$0.10 increment.

In addition to the airport uniform rate of fare, a taxicab operator may charge an "extra" equal to the Airport Trip Fee assessed against the individual taxicab operator by the San Diego County Regional Airport Authority. The extra may not be charged on any trip that does not originate at the airport or on any trip where the taxicab operator does not pay the fee to the San Diego County Regional Airport Authority. The extra charge may only be charged to the customer by utilizing the extra button on the taxicab meter. A driver may not verbally request payment.

34.4 Regulatory Fee Review

The following procedures will be utilized for the establishment of for-hire vehicle regulatory fees.

34.4.1 In accordance with State of California Public Utilities Code Section 120266, MTS shall fully recover the cost of regulating the taxicab and other for-hire vehicle industry. Pursuant to MTS Ordinance No. 11, Sections 1.3(b), 1.4(a), 1.4(d), and 1.5(d), the Chief Executive Officer establishes a fee schedule to effect full-cost recovery and notify affected permit holders of changes in the fee schedule.

34.4.2 The procedure for establishing a regulatory fee schedule will include an annual review of the audited expenses and revenue of the previous fiscal year associated with MTS for-hire vehicle activities. The revised fee schedule will be available for review by interested parties in November each year and is subject to appeal as provided for in Ordinance No. 11, Section 1.5(d).

34.4.3 A fee schedule based on previous year expenses and revenue amounts will be put into effect each January.

NOW THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED that the MTS Board of Directors does hereby freeze the taxicab rates of fare for the airport and the maximum allowable rates of fare for the City at the amounts currently in effect until approximately March 2014.


