2025 TAC Election Permit Holder and Lease Driver Self-Nomination Form

Self-nominations are being accepted from taxicab permit holders and lease drivers who are interested in serving on MTS's Taxicab Advisory Committee (TAC). The TAC is a group of elected and appointed individuals that provide feedback to staff and the MTS Board on taxicab related matters. This year, the TAC will be electing new taxicab permit holders and taxicab lease drivers to be representatives on TAC.

The TAC meets four times per year in the MTS Board Room, located at 1255 Imperial Avenue, Suite 1000 (10th Floor), San Diego, CA 92101. Committee representatives serve a term of three (3) years.

Self-nominations will be included in the ballot for the following permit holder and lease driver membership categories:

- **Permit Holders:**
 - Four seats are designated for permit holders of **ONE TAXICAB ONLY**
 - Two seats are designated for permit holders of **TWO or MORE TAXICABS**
- **Lease Drivers**
 - Three seats for lease drivers (**must have a valid Sheriff's Driver I.D Card**)

All permit holders and lease drivers must be in good standing with For-Hire Vehicle Administration (FHVA) and the San Diego Sheriff's Department. **Completed forms must be submitted via email by JUNE 30, 2025**, to Brenda Jackson, Clerk of the TAC:

The TAC election period will be open for two weeks, **starting on July 7, 2025, ending on July 18, 2025**. The election will be held online. A website link to the election website and voting instructions will be sent via e-mail to all eligible permit holders and lease drivers who provide FHVA with their e-mail contact information.
