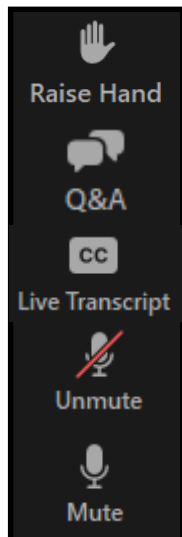

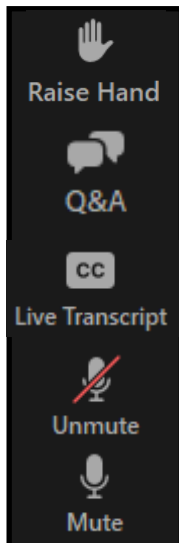

MINUTES

BOARD OF DIRECTORS MEETING OF THE SAN DIEGO & ARIZONA EASTERN RAILWAY COMPANY

October 8, 2024

A meeting of the Board of Directors of the San Diego & Arizona Eastern (SD&AE) Railway Company, a Nevada corporation, was held at 1255 Imperial Avenue, Suite 1000, San Diego, California 92101, on October 8, 2024, at 9:05 a.m. via Zoom and in person.

The following persons, constituting the Board of Directors, were present: Brian Riley, Matt Domen, and David Franklin, Jr. Others in attendance were members from:

San Diego Metropolitan Transit System: Erin Dunn, Karen Landers, Sean Myott
Pacific Southwest Railway Museum: Stephen Hager

1. Approval of Minutes

Mr. Domen moved to approve the Minutes of the October 17, 2023, SD&AE Railway Board of Directors meeting. Mr. Riley seconded the motion, and it was unanimously approved.

2. Statement of Railway Finances

Ms. Dunn reviewed the Statement of Railway Finances for the fiscal year ending June 30, 2024 (attached to the agenda item). Ms. Dunn noted that the anticipated FY 24 revenue is approximately \$4,000 ahead of budget primarily due to the new billboard lease that was effective November 1, 2023. Operating expenses were \$87,000 favorable to budget primarily due to new expenses for outside services and risk management costs coming in lower than budgeted in prior years. Ms. Dunn added that the net income for the fiscal year was \$171,000.

3. Report on San Diego & Imperial Valley Railroad (SD&IV) Operations

Mr. Domen reviewed the SD&IV Periodic Report for activities for the 4th Quarter of 2023 & 1st Quarter of 2024 (attached to the agenda item).

4. Report on Pacific Southwest Railway Museum Operations (Stephen Hager)

Mr. Hager reviewed the Pacific Southwest Railway Museum (PSRM) report for the 4th quarter of 2023 and 1st quarter of 2024 (attached to the agenda item).

Action Taken

Informational item only. No action taken.

5. Report on the Desert Line (Karen Landers)

Ms. Landers gave an update on the Desert Line. Ms. Landers reminded the Board that MTS staff reached out to Caltrans a couple of years ago about Caltrans conducting a feasibility study on the future of the Desert Line. Ms. Landers noted that attempts in the past by private investors have been unsuccessful in planning for a viable line and it became apparent that a significant investment of public funds would be required to study and plan to revive the Desert Line infrastructure in a safe, working condition.

Ms. Landers stated that the public benefit must also be weighed to determine if the project is worth the level of public investment needed. This would involve finding a partner agency and following and carrying out a multitude of government rules. MTS reached out to SANDAG and Caltrans and the next phase would be for a partner agency to conduct a study and analysis.

Ms. Landers stated that the project is in the first phases for SANDAG or Caltrans to get a planning grant. This would allow them to do a feasibility study. HNTB has been hired to conduct a market feasibility study and a public benefit analysis. HNTB is in the fact-finding stage currently engaging with stakeholders in the U.S. and Mexico about the market and type of traffic—such as border-wait times, truck-travel times, vehicles, miles traveled, etc.

Ms. Landers stated that HNTB is also doing a high-level budget cost estimation. Ms. Landers added that she informed HNTB that the condition of the Desert Line has deteriorated since the previous condition reports in 2012. She noted that the plan is to do some drone flights with newer technology than from 12 years ago to try to understand the magnitude of what it would take to rebuild the line. A lot of things would have to fall into place to be able to complete this project and a lot of decisions would have to be made based on real information to determine if the money should be spent on this project.

Ms. Landers reported that HNTB started in July 2023 and it is supposed to take about 12 to 18 months to complete the analysis and we should know more then. Ms. Landers will connect HNTB with SD&IV and Museum personnel to get feedback from the operators about their input and needs related to the rehabilitation of the Desert Line. Ms. Landers also suggested to HNTB that they contact Baja Rail.

Ms. Landers reported that she and staff went out on the line with Rail staff who had tried to clear the track prior to her arrival; however, she noted that they derailed 10 times during her visit. Ms. Landers suggested to HNTB that they reach out to Dan Davis who previously conducted the bridge analysis. She reiterated that the project could be in the tens of millions of dollars and the public benefit analysis would have to be weighed.

Sean Myott stated that since the October 17, 2023, SD&AE Railway Company Board of Directors meeting, the documents listed by bullet points below have been processed by staff. STATEMENT OF RAILWAY FINANCES

RECOMMENDATION:

That the SD&AE Railway Company Board of Directors receive a financial report for the year ending June 30, 2025.

Budget Impact

None.

DISCUSSION:

Attached are SD&AE's financial results for the fiscal year ending June 30, 2025.

As of June 30, 2025, revenue is favorable to budget by \$45,000 and has increased by \$48,000 from the fiscal year ending June 30, 2024. The increase was related to increases across the board for revenue: right of entry permits, lease revenue from billboards and freight fees.

Expenses are \$90,000 favorable to budget primarily due to positive variances in both Outside Services and Risk Management Costs. Compared to the fiscal year ending June 30, 2024, expenses have increased \$15,000 primarily due \$9,000 in outside services related to cleaning up the hazardous materials under the locomotives on the Desert Line in Ocotillo.

The Net Income as of June 30, 2025, was \$204,000.

Periodic Report

In accordance with Section 20 of the Agreement for Operational Freight Service and Control through Management of the San Diego and Arizona Eastern Railway Company activities of interest for the prior year are listed as follows:

2. Marketing

Volume in the 3rd Quarter had an 4.2% increase as compared to the same quarter in 2024. Traffic terminating on SDIY increased 12%, consisting of ethanol, E85, aviation gas, renewable diesel, and plastics. Ethanol and E85 strengthened by small increase in the market share of local gas stations. Traffic into Mexico remained consistent driven by increased spot buys of LPG. Dairy feed, brewery malt and pulp and paper shipments make up the remainder of the traffic.

Days through year to date there were **no** FRA Reportable injuries or Environmental incidents on the SDIV Railroad.

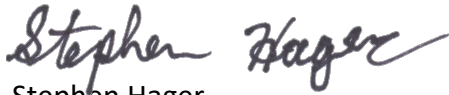

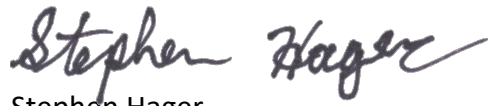
